### **Background Information.**

Plan International is an independent development and humanitarian organization that advances children's rights and equality for girls.

The Conservation and Sustainable Management of Coastal and Marine Ecosystems (COSME) project is a three-year initiative led by Plan International, which brings together several partners and stakeholders to significantly scale up Plan International Kenya's current womenled, climate-resilient livelihoods and coastal management project in Kwale (Msambweni and Lungalunga Sub Counties) and Kilifi (Kilifi North, South and Ganze sub Counties).

#### Scope of Work

Under the supervision of Plan International Representative and the County clerks of work the contractor will:

- Construct plinths for 73 water tanks distributed in 53 schools i.
- Supply and fit gutters for the 73 water tanks to connect them with roof for rain water ii. harvesting
- iii. Supply 73 taps and Fit tanks with the taps (brass type of taps)
