ACTIVITY DETAILS

Activity Name: Procure and distribute solar kits and solar panels

ACTIVITY INTRODUCTION

COSME project aims at increasing access to resilience building assets and opportunities for women. Specifically focusing on providing Solar and improved technology solutions to targeted women to reduce fuelwood harvesting, improve air quality, and reduce time poverty. These Terms of Reference aims at procuring and distributing solar lighting kits to targeted women. In addition, the recipients will be trained on operation, maintenance and the benefits of the kits in relation to environmental conservation and- in reducing time poverty.

ACTIVITY OBJECTIVE

The activity aims to achieve the following:

- Procurement of solar lighting kits for 1500 direct participants
- Distribution of solar lighting kits to 1500 participants.
- Train recipients on operation, maintenance and the benefits of the kits in relation to environmental conservation and- in reducing time poverty.

DELIVERY METHODOLOGY

The activity will be implemented by a supplier/vendor specializing in solar energy technology with an established presence in Kwale and Kilifi. The selected vendor should possess the **capacity to conduct or facilitate comprehensive training for recipients on basic household system installation**. Preference will be given to vendors with accessible agents or retail outlets where participants can report system failures and seek support. The vendor must offer a **minimum two-year warranty** for the products and provide a dedicated customer service line for recipients to obtain guidance on system operation and maintenance. Distribution of the kits will be done to members of Conservation groups working with the COSME project across Kwale (Lungalunga & Msambweni Sub-counties) and Kilifi (Mwangea in Ganze, Takaungu & Chonyi) at their respective meeting points.

DESCRIPTION OF THE SOLAR LIGHTING SYSTEM

- 1. Full package lithium ion NMC battery control unit, 12V, fitted with ports and cables for connecting bulbs and for charging electronics such as mobile phone. The battery must be protected by a casing for safety of the users.
- 2. A compatible solar panel sufficient to charge the battery specified above
- 3. At least three bulbs that can be replaced in case of damage.
- 4. Equipped with a security system that can help to switch the device off in case of theft.

5. At least two-years warrant.

EXPECTED OUTPUTS

- 1. 1500 participants provided with solar lighting kits
- 2. 1500 participants trained on operation, maintenance and the benefits of the kits in relation to environmental conservation and in reducing time poverty.
- 3. 1500 solar lighting kits installed in the homes of the community members in the 5 locations.
