1.0 Background Information.

Plan International is an independent development and humanitarian organization that advances children's rights and equality for girls.

We wish to invite bids from eligible ISPs for the provision of an internet connectivity solution for the Plan International Kwale Office.

We thereby request your best competitive rates.

Successful bidders will be awarded a one-year contract renewable for internet connectivity to Plan International at their quoted price. The contract will be under Plan International Inc., a VAT exempted entity, as per the new directives guided by the Kenya Revenue Authority and the Ministry of Foreign affairs.


2.0 Internet connectivity solution Kwale

Plan International Inc. - Kwale Office, located in Kwale town, is seeking to enhance its internet connection speed and reliability by transitioning to a new Internet Service Provider (ISP). (The demand is necessitated by inability of the current provider to meet the SLA on uptime percentage and inept support).

We are specifically looking for an ISP that can deliver stable and reliable last-mile Fiber Optic connectivity. Additionally, we require a set of 4 usable Public IPs for our gateway router.

Currently, our last mile solution is Fiber Optic with a bandwidth capacity of 20 Mbps download and 20mbps upload. Our goal is to improve this setup to enhance reliability and ensure uninterrupted business continuity.

4.0 Equipment

- 1. Plan will provide Routing Devices, Switches, and structured LAN for the site.
- 2. Plan will provide clean electricity for all connectivity devices.
- 3. The ISP will be required to provide link termination equipment.
- 4. ISP should provide a quotation for any other equipment they may be needed besides the specified above.
- 5. The service should include access to Multi Router Traffic Grapher (MRTG) for active monitoring of traffic load on network interface

### 5.0 Technical and Financial proposal

The bidders will be expected to present a detailed technical and financial proposal.

The proposed technical proposal must demonstrate how the ISP intends to approach the assignment.

The proposed financial proposal is as below:

### 6.0 Time frame

This assignment is expected to be completed within two weeks (14 calendar days) from receipt of our commitment document. The deliverables include successful installation, configuration, and provision of requisite bandwidth, and setup of bandwidth/traffic monitor with SLA.

Those who demonstrate the following will have an advantage:

- Proposal based on a proper site survey and assessment.
- Those who can provide easy-to-use monitoring services whose summary reports can be printed for management use.
- Clearly indicate costs and ownership options of the equipment.
- Clearly indicate monthly recurrent cost inclusive of all taxes. (is there a way we can take advantage of the Tax exemption on this?)
- Clearly indicate the installation costs (if any).

- vii. Indicate if you accept to offer services as per the credit policy of payment within 30 days after service provision-mandatory
- viii. A technical proposal
- ix. A financial proposal
- x. Indicate whether prices are inclusive or exclusive of VAT where applicable-mandatory
