Bidders are expected **to factor all logistical requirements, ground preparation costs, and any other associated works into their financial and technical proposals.** Failure to conduct a site visit will not be accepted as justification for cost variations or implementation challenges at a later stage.

Site should be visited within normal working hours 8:30-4:30 Pm.
Notify the officers on the ground a day prior to the visit.

Please note that any additional fabrications, including roofing works, will be undertaken at a later stage and do **not** form part of the current tender scope.

Q 7 . You have indicated supply, delivery and installation of the containers but have not indicated whether the transport and offloading costs should form part of the container cost or the transport and offloading should be considered separately to avoid the costs being seen as very high?

The financial proposal/Quotation should include the cost of supply, delivery and installation inclusive of all applicable statutory deductions.
